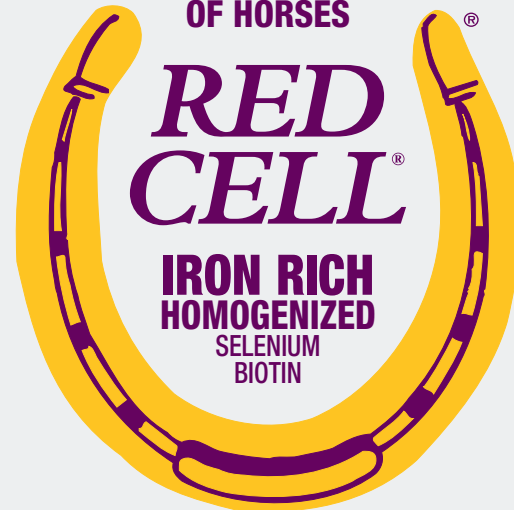

FEEDING DIRECTIONS:

Horses in training: Feed 2 fluid ounces of Red Cell® supplement daily. Horses not in training: Feed 1 fluid ounce of Red Cell® supplement daily. Feed Red Cell® supplement by mixing into daily feed ration or orally with a dose syringe.

IMPORTANT: Intake of supplemental selenium should not exceed 0.3 ppm on a complete ration basis. Store in a cool, dry place. Shake well before using. Keep from freezing. Close container after each use.

CAUTION: Follow label directions. The addition to feed of higher levels of this premix containing selenium is not permitted. Store in area inaccessible to children and animals. Excessive amounts of selenium may be toxic. This product should not be fed to copper sensitive animals, such as sheep.

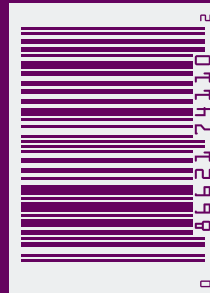
